COMMITTEE IS EXPECTED TO MEET AT LEAST ONCE A WEEK AND FOR APPROXIMATELY 4 TO 5 WEEKS. A RECOMMENDATION OF A PROPOSED SHORT-TERM RENTAL ORDINACE WILL BE SUBMITTED TO PLANNING AND ZONING HISTORICAL APPROPRIATNESS COMMITTEE FOR REVIEW. AT THAT TIME, AD HOC COMMITTEE WILL BE DISOLVED.
