# Mayor Hernandez-

Discussion on alternate commissioners. Chair needs to assign alternate commissioners at the beginning of meeting before quorum. Alternate commissioner will participate in discussion but not able to vote unless there is a commissioner that is absent.

If there is no quorum, meeting can still be held, just won't be able to vote on any action items. Items such as public comment, staff/commissioner comments.

If chairperson and vice-chair are absent, secretary will conduct meeting. If secretary is also absent, present commissioners will elect one amongst themselves to conduct the meeting that night only. Most importantly, all meetings should be consistent.

Rolling quorum outside of a meeting setting. In public physical contact, group message, group email, etc with 3 commissioners or more is considered a rolling quorum.

Notices for public meetings/hearings need to be posted 72 hours before meeting and in assigned areas when approved at the beginning of the year through resolution.

As per Open Meeting Act, notice requirements are only agenda and minutes, not packets.

Close session is available for PZHAC but needs to be listed on the agenda.

Special meetings can be any day or time just needs to have a 72-hour notice.

Discussion on what a consent agenda is and how to remove an item from the consent agenda to put as an action item.

Chair should be recognized first before any discussion whether from staff, commissioners or public.

#### Chairperson Lucero

What conditions do the BOT have to meet to override our recommendation on cases that are appealed?

#### Mayor Hernandez

Board of Trustees have final decision and take recommendations from the commission but also need to consider other factors that are not within the code. Trustees can also interpret the code differently. PZHAC should not take offense if appeal is overturned.
