- 3. Renewal application submitted after March 15th, will include a \$10 annual late fee.
- 4. All fees roll over to the following year until paid in full.
- 5. Parking MUST be paid along with your renewal fee if applicable. If you are unsure if you need to pay for parking, please email: comdev@mesillanm.gov
- 6. Any business delinquent passed 30 days after the due date, could be subject to additional fines up to including license termination. Business would need to reapply as a new business if license is revoked.
- 7. First time applications MUST be filled out completely and submitted along with:
 - Copy of driver's license
 - Copy of current tax ID # registration
 - Landlord/Tenant Agreement if renting
 - Business Plan (what is your business is about and how you propose doing it)
 - All fees paid (to include any delinquent charges)
